ARTICLES OF INCORPORATION OF RACA VENTURES, INC.

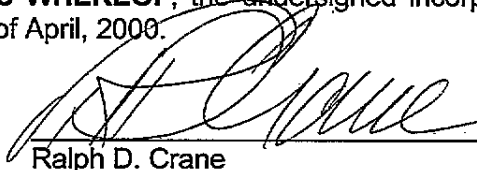

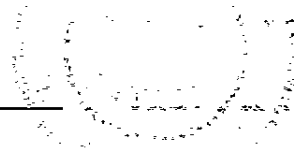

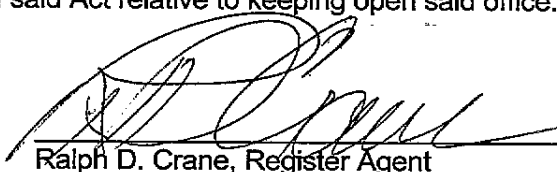
