I, the undersigned, hereby make, subscribe, acknowledge and file with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a business organization for profit in accordance with the laws of the State of the State of Florida.

ARTICLE I
Name

The name of this corporation shall be **TWO THOUSAND CONNECTION INCORPORATED.**

ARTICLE II
Address

The address of the principal office and the mailing address of this corporation shall be:

ARTICLE III
Existence of Corporation

This corporation shall have perpetual existence.

ARTICLE IV
Purposes

The general nature of the business to be transacted by this corporation or the objects or purpose of the corporation shall be as follows:

- (a) To buy, own, manage, and invest in real estate property.
- (b) To engage in business which will promote the above objective.
- (c) To engage in any lawful business without being limited to real estate for which a corporation may be established under the incorporation laws of the State of Florida.
- (d) To engage in import and export business.
- (e) The corporation may engage in the transaction of any and all-lawful business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE V
Capital Stock

(a) The total number of shares of capital stock authorized to be issued by the corporation shall be 10,000 shares having a par value of \$1.00 per share. All stock when issued shall be paid for and shall be nonassessable.




