**ARTICLES OF INCORPORATION
OF
JET ACQUISITIONS, INC.**

ARTICLE I

The name of this corporation is **JET ACQUISITIONS, INC.**

ARTICLE II

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation.

ARTICLE III

This corporation is organized for the purpose of transacting and engaging in any and all activity or business permitted under the laws of the State of Florida or of the United States.

ARTICLE IV

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is 10,000 shares of common stock at \$1.00 par value. Said stock shall be issued pursuant to a plan under Section 1244 of the Internal Revenue Code of 1986, as amended.

ARTICLE V

The holders of the common stock of this corporation shall have preemptive rights to purchase, at prices, terms and conditions that shall be fixed by the Board of Directors, those shares of the common stock of this corporation which may be issued from time to time for money, property or past services in addition to that stock authorized and issued by the corporation. The preemptive right of any holder is determined by the ratio of the authorized and issued shares of common stock held by the holder and all shares of common stock currently authorized and issued.

ARTICLE VI

The street address of the initial registered office of this Corporation is 355 Southeast 7th Street, Dania Beach, FL 33004, and the name of its initial registered agent at said address is William J. DiMauro.

ARTICLE VII

The principal office and mailing address of this Corporation will be: 355 Southeast 7th Street, Dania Beach, FL 33004.




