ARTICLES OF INCORPORATION

OF

ARTICLE I

The name of this corporation is JAMES BEDNARCZYK, P.A. whose principal address is 972 N.W. 106th Terrace Pembroke Pines, Florida 33024

ARTICLE II

The general nature of the business to be transacted by this corporation is to engage in Real Estate, a business permitted under the laws of the State of Florida.
