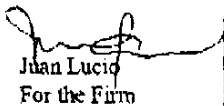
As of this date, the check had not been cashed nor we have received any correspondence from your office with respect of the filing.

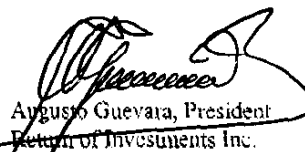
