### ARTICLES OF INCORPORATION

# ARTICLE I. NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the Corporation shall be: SAINT JUDE CARDINAL REALTY, INC., and the principal place of business is: 3600 South State Road 7, Suite #308, Miramar, Florida 33023.

### ARTICLE II. TERM OF EXISTENCE

# ARTICLE XI. RESTRICTIONS ON TRANSFER OF STOCK

# ARTICLE XIII. SHAREHOLDER OUORUM AND VOTING

Fifty-one (51%) percent of the shares entitled to vote, represented in person or by proxy, shall constitute a quorum of a meeting of Shareholders.

If a quorum is present, the affirmative vote of Fifty-One (51%) percent of the shares represented at the meeting and entitled to vote on the subject matter shall be the act of the Shareholders.

# ARTICLE XIV. DIVIDENDS

Dividends may be paid to Shareholders (only out of the H00000016389

# ARTICLE XV. MANAGEMENT OF CORPORATION BY DIRECTORS
