ARTICLES OF INCORPORATION
OF

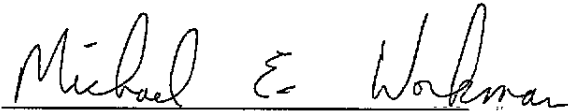
ARTICLE VI

The undersigned incorporator has executed these Articles of Incorporation this 10th day of April, 2000.

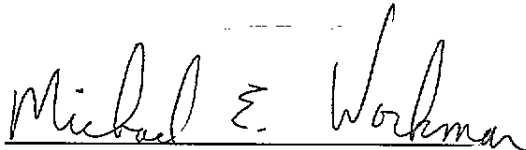
