## ARTICLE I - NAME AND ADDRESS

The name of the corporation shall be: SIEBERT & ASSOCIATES, INC. and whose mailing address shall be: 5584 Dean Road, Orlando, FL 32817.

### **ARTICLE II - DURATION**
