ARTICLES OF INCORPORATION

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is Jim-Joe Enterprises, Inc., and the principal address is 960 Harbor Lake Court, Safety Harbor, FL 34695.

ARTICLE II - REGISTERED OFFICE AND AGENT
