The undersigned desiring to form a corporation, for profit, pursuant to chapter 607 or 621 F.S., do hereby state the following:

Article I

The name of the corporation is Decks and Docks, Inc.
817 Waterside Lane Bradenton, Florida 34209

Article II

The period of its duration is perpetual.

Article III

The purpose is to engage in any activities or business permitted under the laws of the of The United States and The State of Florida.

Article IV

The corporation shall have authority to issue Five Hundred (500) Shares, all of one class " common ", One Dollar par value.

Article V

The address of its initial registered office is 817 Waterside Lane, (Manatee County) Bradenton, Florida 34209. The name of its intial statutory agent at said address is Joy Whitmer.

Article VI

The business and the affairs of this corporation shall be managed by a Board Of Directors, which shall be elected by the shareholders and serve as provided in the bylaws. The number of the members of the Board Of Directors may either be increased or decreased from time to time by the bylaws, but shall never be less than one (1). 
