**ARTICLES OF INCORPORATION OF  
National Café of Central Florida, Inc.**

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such a corporation:

**ARTICLE I  
Name**

The name of the corporation shall be National Café of Central Florida, Inc.

**ARTICLE II  
Duration**

The corporation shall have perpetual existence.

**ARTICLE III  
Purpose**

The purpose of the corporation is to engage in any activities of business permitted under the laws of the United States and of Florida.

**ARTICLE IV  
Capital Stock**

The corporation is authorized to issue 1,000 shares of common stock, at a par value of ONE (\$1.00) DOLLAR PER SHARE. The corporation is authorized to issue only one type of stock.

**ARTICLE V  
Initial Registered Office and Agent**

The name and address of the initial registered agent and officer of the corporation is Manfred Reidinger, whose mailing address is 12667 Maribou Circle, Orlando, FL 32828. This is also the business mailing address.

**ARTICLE VI  
Initial Board of Directors**

The corporation shall have TWO(2) directors initially. The number of directors may be increased or decreased from time to time by amendment of the bylaws in the manner provided by law, but shall never be less than ONE (1). The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

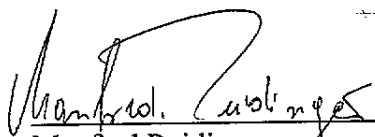
**ARTICLE X**

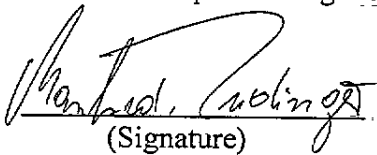
