ARTICLES OF INCORPORATION

OF

THE STROH GROUP, INC.

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

1. Name and Address. The name of the Corporation shall be THE STROH GROUP, INC.. The mailing address of the Corporation shall be 155 Woodcreek Drive North, Safety Harbor, Florida 34695.
2. Duration. The Corporation shall have perpetual existence.
3. Purpose. The purpose of the corporation is to engage in any activities of business permitted under the laws of the United States and of Florida.
4. Capital Stock. The corporation is authorized to issue 10,000,000 shares of common stock, at nor par value.
5. Initial Registered Office and Agent. The name and address of the initial registered agent and office of the Corporation is James H. Stroh, whose mailing address is 155 Woodcreek Drive North, Safety Harbor, Florida 34695.
6. Initial Board of Directors. The corporation shall have ONE (1) director initially. The number of directors may be increased or decreased from time to time by an amendment of the Bylaws in the manner provided by law, but shall never be less than ONE (1). The name and address of the person who is to serve as the initial director is James H. Stroh, whose mailing address is 155 Woodcreek Drive North, Safety Harbor, Florida 34695.
7. Incorporator. The name and address of the incorporator is James H. Stroh, whose mailing address is 155 Woodcreek Drive North, Safety Harbor, Florida 34695.

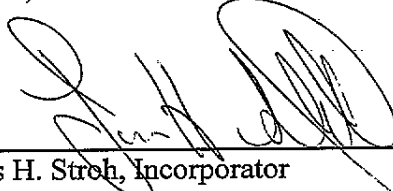
8. Bylaw Amendment. The power to adopt, alter, amend or repeal the Bylaws of this corporation shall be vested in the Board of Directors.

9. Indemnification. The corporation shall indemnify any officer or director, or any former officer and director, to the full extent permitted by law.

10. Informal Action of Directors. If all of the Directors severally or collectively consent in writing to any action taken or to be taken by the corporation, and the writing evidencing their consent are filed with the Secretary of the corporation, the action shall be valid as though it had been authorized at a meeting of the Board of Directors.

11. Amendment of Articles. This corporation reserves the right to adopt, alter, amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, in accordance with Florida law.
