The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

- Name and Address. The name of the Corporation shall be THE STROH GROUP,
 INC.. The mailing address of the Corporation shall be 155 Woodcreek Drive North, Safety Harbor,
 Florida 34695.
 - 2. <u>Duration</u>. The Corporation shall have perpetual existence.
- 3. <u>Purpose</u>. The purpose of the corporation is to engage in any activities of business permitted under the laws of the United States and of Florida.
- 4. <u>Capital Stock</u>. The corporation is authorized to issue 10,000,000 shares of common stock, at nor par value.
