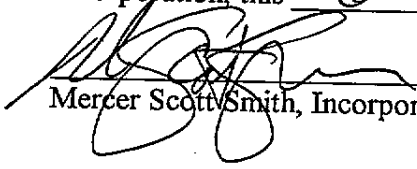
ARTICLE VI. LIABILITY OF STOCKHOLDERS

ARTICLE VII. AMENDMENTS

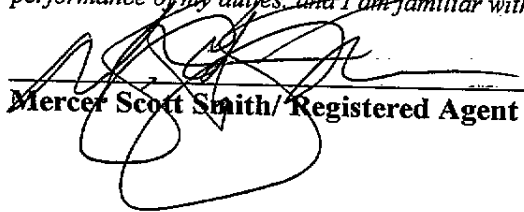
