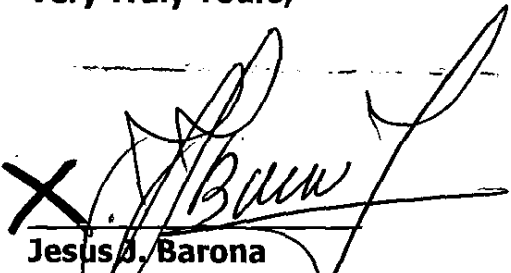
The purpose of this correspondence is to request that you kindly relieve us of the late fees currently placed upon our above referred to organization for the 2003 UBR.
