ARTICLES OF INCORPORATION PALM DESIGN/BUILD SOLUTIONS, INC.

ON THE SES The undersigned, acting as incorporator of a corporation for profit under the Alabama General Corporation Act, adopts the following Articles of Incorporation: for such corporation.

ARTICLE I.

The name of this corporation is PALM DESIGN/BUILD SOLUTIONS, INC. and the principal place of business shall be 1791 North Pearl Street, Crestview, FL 32536.

ARTICLE II.

DURATION: The corporation shall exist perpetually.

ARTICLE III.

PURPOSE: The purpose or purposes for which this corporation is organized is to engage in building and remodeling homes or any activity or business permitted under the laws of the United States and the State of Florida. This shall be a general purpose corporation. Its goals and purposes shall be determined by its directors.
