ARTICLES OF INCORPORATION

OF

ADRIANSEN & ASSOCIATES, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Flörida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the Corporation shall be ADRIANSEN & ASSOCIATES, INC.
