## **ARTICLE VIII – AMENDMENTS**

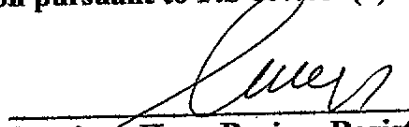
**The Article of Incorporation may be amended in the manner provided by law.
