The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following:

ARTICLE ONE

The name of the corporation shall be **CRAZY DAVE'S DISCOUNT FIREWORKS, INC.**

The term of existence of the corporation is perpetual.

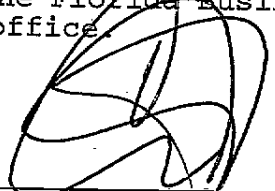

ARTICLE TEN

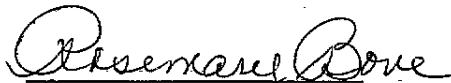
