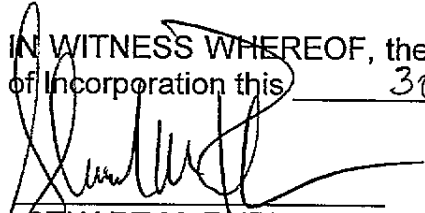
ARTICLE IX-INDEMNIFICATION

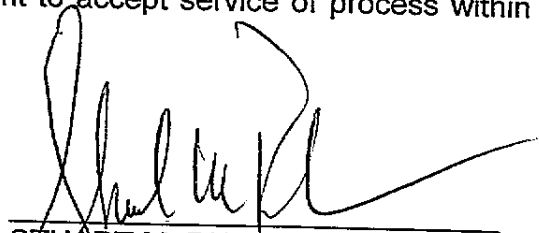

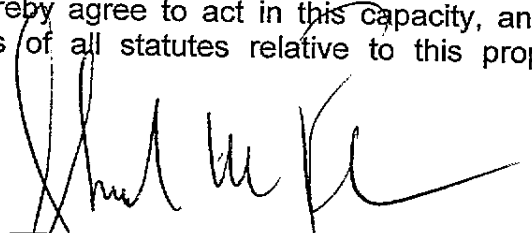
