ARTICLES OF INCORPORATION

This is to certify that the undersigned does hereby establish a corporation under and by virtue of the provisions of Chapter 607, Title XXXVI, Florida Statutes and acts amendatory thereof, for the purposes and under the corporation hereinafter mentioned, and to that end, does, by these Articles of Incorporation, set forth the following:

ARTICLE I

The name of the corporation is KEY WEST FOR YOU, INC.

ARTICLE II

The address of the initial registered offices of the corporation shall be 1117 Duval Street, Key West, Florida 33040, and the name of the initial registered agent for the corporation shall be Thomas Favelli, a resident of the State of Florida.

ARTICLE III

ARTICLE IV

The nature of the business and the objects and purpose or purposes to be transacted,


