**ARTICLE I**

The name of this corporation is **JEWELRY BROKERS, INC.**

**ARTICLE II**

The corporation is to exist perpetually, commencing on the date of filing and recording of these Articles.

## ARTICLE X





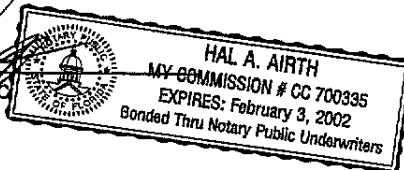
