

The undersigned incorporator Linda Roemer, Ph.D., A.R.N.P. - C. hereby forms FRIDLEY ROEMER HCS, INC., a corporation for profit under the Florida General Corporation Act and other laws of the State of Florida.

1. NAME OF CORPORATION AND INITIAL ADDRESS: The name of this corporation shall be FRIDLEY ROEMER HCS, INC. and its address is 2411 Country Club Drive, Lynn Haven, Florida 32444.

2. TERM OF EXISTENCE: This corporation shall exist perpetually unless dissolved according to law.

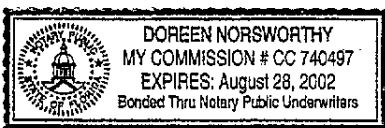
