ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this Corporation is I-Matrix Connections, Inc.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on April 17, 2000.

ARTICLE III - PURPOSE

This Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - CAPITAL STOCK
