

ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

1. The name of the corporation is REWIRE, INC.
2. The period of its duration is perpetual.
3. The purpose is to engage in the cable installation or any other activity or business permitted under the laws of the United States and Florida.
4. The corporation shall have the authority to issue 10,000 shares, all of one class, \$1.00 par value each.

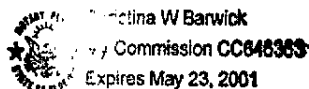
