# ARTICLES OF INCORPORATION OF C & T CRANE SERVICES, INC.



### ARTICLE I - NAME

The name of this corporation is C & T CRANE SERVICES, INC. with a principal office and mailing address of P. O. Box 460, Belleview, Florida 34421-0460.

### ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of the Articles with the Department of State.


