ARTICLES OF INCORPORATION  
OF  
MERGE LEFT, INC.  
A FLORIDA CORPORATION

The undersigned, acting as Incorporator of Merge Left, Inc., a Florida corporation (the "Corporation") under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I

NAME

The name of the Corporation is Merge Left, Inc. and the street address of the initial principal office of the Corporation is 530 E. Tall Oaks Drive, Palm Beach Gardens, Florida 33410.

ARTICLE II

PURPOSE

The Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE III

CAPITAL STOCK
