ARTICLES OF INCORPORATION OF

BURGER & TRAILOR, P.A.

ARTICLE I.

CORPORATE NAME

The name of this corporation shall be: BURGER & TRAILOR, P.A.

ARTICLE II.

NATURE OF CORPORATE BUSINESS

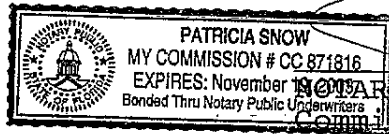
