ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of the corporation is SUPER INVESTMENTS, INC. hereinafter called the "Corporation")

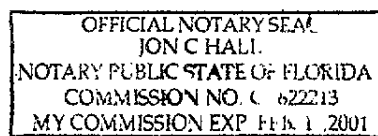
