ARTICLE I.

CORPORATE NAME

The name of this corporation is P & P Florida Landscape, Inc..

DURATION

The corporation shall have perpetual existence, commencing on the date of the execution and acknowledgment of these Articles or upon filing.

BYLAWS

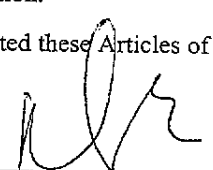
The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Directors.

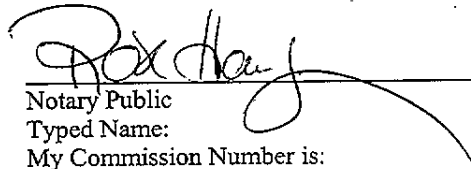

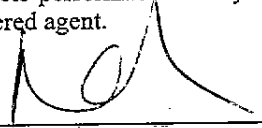
