

ARTICLES OF INCORPORATION

OF

ARTICLE I

CORPORATE NAME

The name of the corporation shall be: BOGGY CREEK PARASAIL RIDES, INC. The principal place of business of this corporation shall be 3702 Big Bass Road, Kissimmee, FL 34744.

ARTICLE II

PREEMPTIVE RIGHTS




ARTICLE XII
