**ARTICLES OF INCORPORATION  
OF  
SUPPORT ASSOCIATES OF TAMPA BAY, INC.**

In compliance with the requirements of F.S Chapter 607, the undersigned, being of natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the corporation is "Support Associates of Tampa Bay, Inc. and is perpetual.

**ARTICLE II**

The existence of the corporation shall begin on July 1, 2000.

**ARTICLE III**

The purpose of the corporation, "Support Associates of Tampa Bay, Inc." is to assist in coordination of services for people with disabilities.

**ARTICLE IV**

**ARTICLE V**

The maximum number of shares this Corporation is authorized to issue is 5,000, all of which is Common Shares.
