# ARTICLES OF INCORPORATION

## ARTICLE ONE NAME

The duration of the corporation is perpetual.

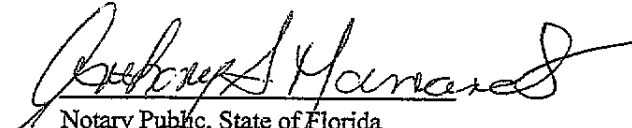
