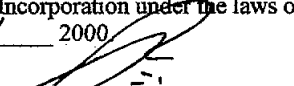
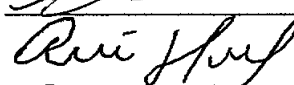

These articles of Incorporation should be affected on Date of Execution and Acknowledgement.

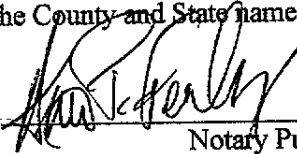
