ARTICLES OF INCORPORATION
OF
THE OAKS OF VERO, INC.

We, the undersigned, jointly and severally agree with each other to associate ourselves and our successors together as a corporation for the profit under the laws of the state of Florida, the following Articles of Incorporation, to wit:

ARTICLE I

The corporate name shall be THE OAKS OF VERO, INC.

ARTICLE II

The Corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE III

1. The number of shares of authorized capital stock of the corporation shall be Seven Thousand Five Hundred (7,500) shares of common stock with a nominal par value of One Dollar (\$1.00) each.
2. The capital stock may be paid for in property, labor, services or cash at a just valuation to be fixed by the stock holders. All of such stock shall be fully paid and nonassessable.

ARTICLE IV

The amount of capital with which this corporation will begin business shall not be less than Five Hundred Dollars (\$500.00).

ARTICLE V

The term for this corporation shall be perpetual.

ARTICLE VI

The principal office of the Corporation shall be at 39 Treasure Circle, Sebastian Florida, 32958. The Corporation shall have such other places of business in the State of Florida as the nature and progress of the business of the corporation shall from time to time render necessary or desirable. The stockholders may from time to time move the principal office to any other address in Florida.

ARTICLE VII

The corporation shall initially have two (2) Directors to hold office until the first Annual meeting of Shareholders and until their successors shall have been duly elected and qualified, or until their earlier resignation removal from office, or death. The number of Directors may be either increased or decreased, from time to time, in accordance with the By-laws of the corporation. The names of the initial Directors of the Corporation are:

ARTICLE VIII

ARTICLE IX


The initial registered office shall be at 39 Treasure Circle Sebastian, FL 32958 registered agent at the same address shall be PIERRE PAQUETTE.

ARTICLE X

1. When stock holders so determine, any increase of the common stock shall be first offered pro-rata to the common stockholders who may desire to subscribe for such stock in relation to their present holdings.

2. Every amendment shall be approved by the stockholders at a stockholders meeting by fifty-one (51%) percent of the stock entitled to vote thereon.
3. Any meeting of the stockholders may be held within or without the State of Florida.
4. Officers of this corporation need not be stockholders.

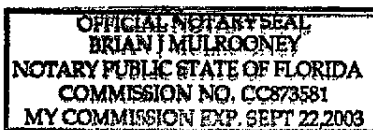


