ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is JCL, Inc.



ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be: 3655 Coral Tree Circle Coconut Creek, Florida 33073

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK
