Thank you for taking time on the phone to discuss the situation with my husband's corporation and the paperwork required to keep it active. I appreciate your help so very much.

Pursuant to our discussion, I am writing this letter to ask for a reinstatement of this corporation. We live in a rural area and have a very difficult time getting our mail delivery service correctly. Back last year, we did not get the forms required to fill out. Later in the year we received a letter saying Jeff's business was no longer active, but after a phone call, the woman at the Incorporations office told me to file a form and send a check for \$150.00 which we did, as instructed. This year, I remembered the form we were supposed to file was supposed to be filed in April, but no form was ever received. I contacted your office today and discovered that our letter and check were sent back to us on December 6 asking for more information. This too was not received and therefore, not returned as requested.

Once again, I am requesting a waiver of the fee to reinstate Jeff's business. I will be checking with the CPA's office to see if it is okay if we have the forms sent there so this problem does not continue. In the meantime, kindly process our request for a reinstatement of this corporation. I am enclosing a check in the amount of \$300 as explained for 2001 and 2002. I am also enclosing the form that we downloaded from the internet for the report, as you also directed.
