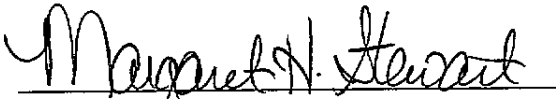
ARTICLE NINE

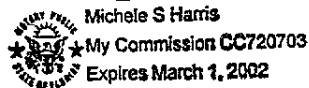

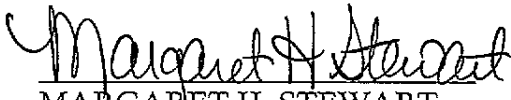

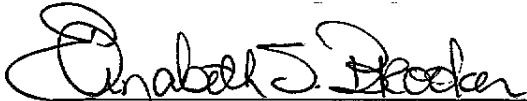
