The incorporator of Jack Hamel & Associates, Inc. who by his signature hereby acknowledges the adoption of these Articles of Incorporation, is:

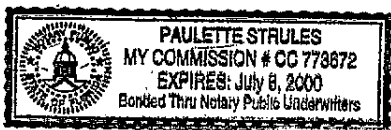
