ARTICLES OF INCORPORATION

OF

ARTICLE I

NAME

The name of the corporation is U P COMPUTER INC, and the mailing address is: 2940 N.W 99 Place, Miami, Fl. 33172.

ARTICLE II

NATURE OF BUSINESS

This corporation is being formed for the following purposes:

To conduct any and all business activities permitted by the laws of the


