In compliance with the requirements of Florida Statutes, Chapter 607, the undersigned, being a natural person, do hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the corporation ("Corporation") is: KTTR Advisors, Inc.

**ARTICLE II**

Pursuant to Section 607.0203, Florida Statutes, this Corporation shall commence upon the date of execution of these Articles of Incorporation. This Corporation shall have perpetual existence.
