**ARTICLES OF INCORPORATION**

**OF**

The Subscriber to these Articles of Incorporation is a natural person over the age of 18 years, duly licensed by the State of Florida to conduct professional services pursuant to Section 458, of the Florida Statutes, who present these Articles for the formation of a professional corporation under the Professional Service Corporation and Limited Liability Company Act, Chapter 621 of the Florida Statutes and other applicable laws of the State of Florida:

**ARTICLES I: NAME OF THE PROFESSIONAL CORPORATION**

The name of the Professional Corporation is MOHAMMAD J. LATIF-JANGDA, M.D., P.A., hereinafter referred to as the "Professional Corporation".

**ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS**

The address of the principal office of the Professional Corporation is 3341 N. University Dr., Suite #1, Davie, FL 33024 and the mailing address is 5722 S. Flamingo Road, #315, Cooper City, FL 33330.

**ARTICLE III: DURATION OF THE PROFESSIONAL CORPORATION**

The period of duration of the Professional Corporation shall be perpetual unless dissolved according to law.

**ARTICLE IV: PURPOSE OF THE PROFESSIONAL CORPORATION**

The purpose for which the Professional Corporation is organized to provide professional medical services to individuals and groups pursuant to Chapter 458 of the Florida Statutes, through individuals authorized by the Florida Department of Business and Professional Regulations to render such services as individuals.

**ARTICLE V: AUTHORIZED SHARES**

The Professional Corporation is authorized to issue Five Thousand (5,000) shares of common stock with a par value of \$1.00 per share. All stock shall be of one class. The Board of Directors may authorize the issuance of such stock to such person(s) upon such terms and for such consideration as they may deem appropriate; however, none of the shares of the Professional Corporation may be issued to anyone other than, a professional corporation, a professional limited liability company, or an individual who is duly licensed or otherwise legally authorized to render the same specific professional services as those for which the incorporation was incorporated.

**ARTICLE VI: PREEMPTIVE RIGHTS**

The Professional Corporation elects to have preemptive rights. Every shareholder, upon the sale for cash of any new or reissued stock of the Professional Corporation, shall have the right to purchase their pro-rata share thereof at the price at which it is offered to others.

**ARTICLE VII: INITIAL REGISTERED OFFICE AND REGISTERED AGENT**

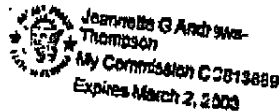
