The Subscriber to these Articles of Incorporation is a natural person over the age of 18 years, duly licensed by the State of Florida to conduct professional services pursuant to Section 458, of the Florida Statutes, who present these Articles for the formation of a professional corporation under the Professional Service Corporation and Limited Liability Company Act, Chapter 621 of the Florida Statutes and other applicable laws of the State of Florida:

ARTICLES I: NAME OF THE PROFESSIONAL CORPORATION

The name of the Professional Corporation is MOHAMMAD J. LATIF-JANGDA, M.D., P.A., hereinafter referred to as the "Professional Corporation".

ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS
