**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF  
VANGUARD ACQUISITION CORP.**

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is VANGUARD ACQUISITION CORP. (the "Corporation"), Charter #P00000039753, filed on April 20, 2000.
2. The following Amendment to the Articles of Incorporation was adopted by the sole Director of the Corporation and the sole Shareholder of the Corporation, the number of votes cast being sufficient for approval, on May 23, 2000 in the manner prescribed by Section 607.1003 of the Act:


**ARTICLE I**
