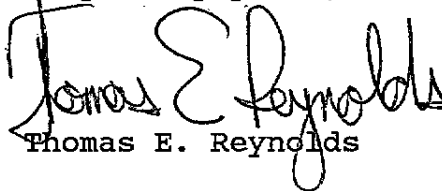

ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I.

NAME

The name of the Corporation is Rock Salt Charters, Inc.

ARTICLE II.

DURATION

The duration of the Corporation is perpetual.

ARTICLE III.

PURPOSE

The general purposes for which the corporation is organized are the following:

A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

B. To do such other things as are incidental to the purposes of the Corporation.

ARTICLE IV.

CAPITAL STOCK

The aggregate number of shares which the Corporation is authorized to issue is 100 shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

ARTICLE V.

INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial Principal Office of the Corporation is 100 Second Avenue North, St. Petersburg, FL 33701, and the name of its initial Registered Agent at that address is Thomas E. Reynolds.

ARTICLE VI.

INITIAL BOARD OF DIRECTORS

The number of Board of Directors constituting the initial Board of Directors is two. The number of Directors may be increased or decreased from time to time in accordance with the Bylaws but shall never be less than one. 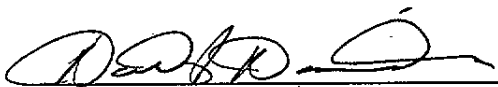

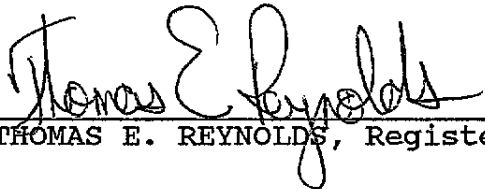
