## AGREEMENT AND PLAN OF MERGER

AGREEMENT AND PLAN OF MERGER, dated April 26, 2000, between THE FORESTVILLE CORPORATION, a Florida corporation, (the "Non-Surviving Corporation") and FORESTVILLE ACQUISITION CORP., a Florida corporation (the "Surviving Corporation" or "FORESTVILLE").

The Non-Surviving Corporation and FORESTVILLE desire to effect the statutory merger of the Non-Surviving Corporation with and into FORESTVILLE, with FORESTVILLE to survive such merger.

- 1. <u>Constituent Corporations</u>. The Non-Surviving Corporation and FORESTVILLE shall be parties to the merger (the "Merger") of the Non-Surviving Corporation with and into FORESTVILLE.
- 2. <u>Terms and Conditions of Merger</u>. The Non-Surviving Corporation (the "Constituent Corporation") shall, pursuant to the provisions of the Florida Business Corporation Act (the "BCA"), be merged with and into FORESTVILLE, which shall continue to exist pursuant to the laws of the State of Florida. Upon the effective date of the Merger (as set forth in paragraph 7) (the "Effective Date"), the existence of the Constituent Corporation shall cease. - 3. <u>Capital Stock</u>. Upon the Effective Date, the Common Stock of the Non-Surviving Corporation presently issued and outstanding shall automatically be converted into the right to receive \_\_\_\_\_ shares of Cornwall Holdings, Inc., a Florida corporation, the parent company of FORESTVILLE.
- 4. <u>Articles of Incorporation</u>. The Articles of Incorporation of FORESTVILLE as of the Effective Date shall be the Articles of Incorporation of the Surviving Corporation and shall continue in full force and effect until changed, altered or amended as therein provided and in the manner prescribed by the laws of the State of Florida.
- 5. <u>Bylaws</u>. The Bylaws of FORESTVILLE as in effect as of the Effective Date shall be the Bylaws of the Surviving Corporation and shall continue in full force and effect until changed, altered or amended as therein provided in the manner prescribed by the laws of the State of Florida.
- 6. <u>Directors and Officers</u>. The directors and officers of FORESTVILLE in office on the Effective Date shall continue to be the directors and officers of the Surviving Corporation, all of whom shall hold their directorships and offices until the election and qualification of their respective successors or until

their tenure is otherwise terminated in accordance with the Bylaws of the Surviving Corporation.

- 7. <u>Effective Date</u>. The Merger shall become effective on the date (the "Effective Date") on which Articles of Merger have been filed with the Department of State of the State of Florida.
- 8. <u>Amendment of Plan of Merger</u>. The Board of Directors of each of the Non-Surviving Corporation and FORESTVILLE is authorized to amend this Plan of Merger at any time prior to the Effective Date, subject to Section 607.1103(8) of the BCA.
