The undersigned, for the purpose of forming a corporation under The Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME. The name of the corporation is: ANGEL INTIMATES, INC., located at 4989 W. Atlantic Ave., Delray Beach, FL 33445.

ARTICLE II. DURATION. The term of existence of the corporation is perpetual.
