ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of the corporation is Jim Wallace Transport, Inc.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.
