We the undersigned, as proper persons, do hereby act as Incorporators in adopting the following Articles of Incorporation for the purpose of organizing a stock corporation pursuant to the provisions of the Florida Stock Corporation Act:

ARTICLE I

The name of the corporation shall be:

The duration of the corporation shall be :

The nature of the business and objects and purposes proposed to be transacted, promoted and carried on, are to do any and all things herein mentioned , as fully and to the extend as natural persons might or could do, and in any part of the world, viz.:
