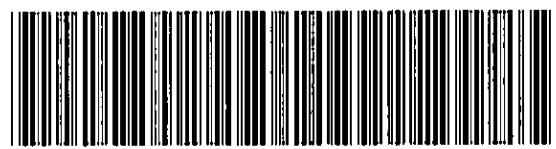

**ARTICLES OF AMENDMENT TO THE  
AMENDED AND RESTATED ARTICLES OF INCORPORATION  
OF  
DRAWLOOP TECHNOLOGIES, INC.**

Pursuant to Sections 607.1003 and 607.1006 of the Florida Business Corporation Act, the Amended and Restated Articles of Incorporation of **DRAWLOOP TECHNOLOGIES, INC.**, a Florida corporation (the "Corporation"), are hereby amended according to these Articles of Amendment:

- FIRST: The name of the Corporation is Drawloop Technologies, Inc.
- SECOND: Article VII of the Amended and Restated Articles of Incorporation is hereby amended in its entirety to read as follows:


**\*ARTICLE VII  
BOARD OF DIRECTORS**

The number and identity of the directors on the Board of Directors of the Corporation shall be governed by the Bylaws of the Corporation, as amended."

- THIRD: The foregoing amendment was adopted by written consent of the Board of Directors and the sole stockholder of the Corporation, respectively, on March 30, 2018, constituting a sufficient number of director and shareholder votes to approve the amendment.

- FOURTH: The effective date of the foregoing amendment is March 30, 2018.
